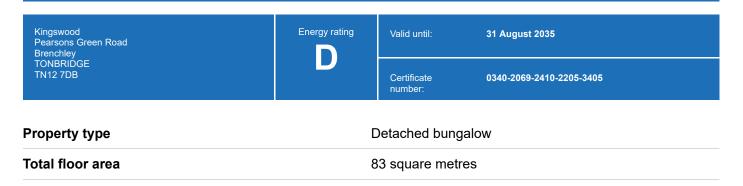

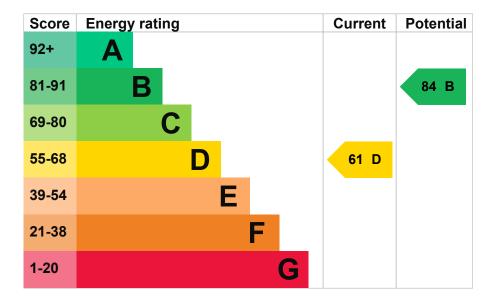
Properties can be let if they have an energy rating from A to E.

## **Energy rating and score**

## How this affects your energy bills

An average household would need to spend £1,206 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

You could save £121 per year if you complete the suggested steps for improving this property's energy rating.

## Impact on the environment

## Steps you could take to save energy

#### Do I need to follow these steps in order?

Yes. Each step builds on the one before it so you can save the most energy.

For example, it's more energy efficient to insulate your home before you buy a new boiler. A well insulated home will lose less heat so you do not have to run your boiler as often.

#### Step 1: Increase loft insulation to 270 mm

#### Step 2: Floor insulation (solid floor)

Typical yearly saving	£231

Typical yearly saving	£712
